LIMITED WARRANTY • WARNING!!

READ THE SAFETY MANUAL BEFORE USING YOUR HELMET

READ CAREFULLY!

VEMAR extends to the original purchaser a limited warranty that the helmet is free of defects in materials and/or workmanship for a period of 5 years upon filling out this warranty registration card and mailing it within 10 days from the purchase date.

WHAT PROTECTION DO I RECEIVE FROM THE WARRANTY?

VEMAR will, at its discretion, repair or replace any helmet it determines to be defective in materials and/or workmanship.

WARRANTY CONDITIONS AND LIMITATIONS

1. This warranty **applies only to the original owner** of VEMAR helmets. VEMAR does not warranty any second hand-merchandise;
2. The validity of this warranty is subject to the proper application of the following claims procedures:
 - (a) The claim must be initiated within eight (8) days of discovery of the alleged defect;
 - (b) Every claim must be submitted to an Authorized VEMAR Dealer, with the understanding, however, that the discretion as to the acceptability of the claim is exclusively VEMAR's;
 - (c) Only an Authorized VEMAR Dealer can ship to VEMAR the allegedly defective helmet, with the accompanying documentation.

PLEASE NOTE! Failure to comply with these procedures will invalidate the claim; in which case the product will be made available to the owner for thirty (30) days and then destroyed.

3. This limited warranty does not apply to:

- a) Costs and transportation damages directly or indirectly arising out of the application of this warranty including, but not limited to, the transportation of the helmet from VEMAR to the owner's domicile, and/or from the owner's domicile to VEMAR;

Damages to the helmet resulting from:

- abuse, alteration, mishandling, misuse including, but not limited to, the failure to use the helmet for the purposes it was designed and manufactured for and, generally, the failure to follow the warnings and instructions contained in VEMAR'S OWNER'S MANUAL;
- Repairwork performed by anyone other than an Authorized VEMAR Dealer;
- Accidents, acts of God, or any cause outside of VEMAR's control;
- The use of corrosive agents on the helmet;
- The prolonged exposure of the product to the elements and/or solvents.

4. Retailers, wholesalers, importers or anyone else besides VEMAR may not modify this warranty in any way.

5. **THIS WARRANTY IS IN LIEU OF ANY AND ALL OTHER WARRANTIES EXPRESS OR IMPLIED, INCLUDING THOSE OF FITNESS FOR A PARTICULAR PURPOSE AND MERCHANTABILITY. IN NO EVENT SHALL VEMAR NOR ANY AUTHORIZED VEMAR DEALER NOR ANY OFFICIAL VEMAR DISTRIBUTOR BE RESPONSIBLE FOR ANY INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES OF ANY NATURE WHATSOEVER.**

6. This warranty does not affect the rights of the consumer afforded by an and all applicable laws or regulations nor the rights arising out of the sale contract with the retailer. In the absence of any applicable law, however, this warranty will be the consumer's only safeguard.
